grkpolebarnhomes.com is the official site for GRK Homes, LLC and information related to and/or contained therein is copyrighted and trademarked to GRK Homes, LLC, with all rights reserved and all logos and photos are used by permission. grkpolebarnhomes.com is committed to providing a safe and secure website for people of all ages. We are dedicated to safeguarding all personal information collected online and to helping our visitors learn how to exercise control over personal information while exploring the Internet. It is our intent that visitors feel comfortable and safe visiting our website and to engage in activities available to them on our website. We do request personally identifiable information from visitors who choose to participate in certain activities available on grkpolebarnhomes.com, as described below. If we were to discover that a child submitted personally identifiable information, grkpolebarnhomes.com would delete the information immediately. As we continue to offer our visitors new and different types of content and services, we may modify our practices from time to time. However, we will treat all personal information we collect in accordance with the privacy notice in effect at the time the information is collected.

#### Our Information Collection and Utilization Policies

At grkpolebarnhomes.com, we do not collect personally identifiable information unless our visitors voluntarily provide it to us. For some activities, such as online polls or surveys, we may ask visitors to provide information that is not personally identifiable. This might include first name only, city or state of residence, age, gender, or information permitting us to post information. For some other activities, such as to our email newsletters, we may ask visitors to provide a name and email address. Visitors who order merchandise or other materials from, or who make payments through, grkpolebarnhomes.com will be required to provide their full name, billing and mailing addresses, email address, telephone number and a credit card number. If the order is being shipped to a third party, we will also need the recipient's name and mailing address. Before collecting information in connection with a grkpolebarnhomes.com order, we will verify the validity of the purchaser's credit card. On occasion, we might solicit additional voluntary information regarding shoppers' personal shopping references. When a child under thirteen participates in another ongoing activity that requires the collection, retention, and use of personal information, we will also ask for a parent's email address so that we can notify the parent that we have received personal information from their child. We do not knowingly collect names and email addresses from children under thirteen for these types of activities without notifying the parent via email and giving the parent the option to remove their child's email address from the applicable database for that activity. For specific onetime requests we receive from visitors, email addresses are collected and used only in connection with the specific onetime request. If we were to discover that a child submitted personally identifiable information, grkpolebarnhomes.com would delete the information immediately.

#### Use of Information

We use visitors' personal information for internal purposes only, such as enabling visitors to subscribe to our online newsletter, or to order from or make payments to GRK Homes LLC through grkpolebarnhomes.com. We never sell, rent, or otherwise share our visitors' personal information with third parties. We may disclose personally identifiable information in response to legal process, for example, in response to a court order or a subpoena. We also may disclose such

information in response to a law enforcement agency's request, or where we believe it is necessary to investigate, prevent, or take action regarding illegal activities, suspected fraud, situations involving potential threats to the physical safety of any person, violations of our terms of use, or as otherwise required by law. In addition, we may transfer information about you if we are acquired by or merged with another company. We will not use or transfer personally identifiable information in ways that are materially different from the ones described above without also providing parental notification of such practices and obtaining consent for any materially different uses.

#### Cookies and Web Beacons

grkpolebarnhomes.com may use a software technology called "cookies." Cookies are small text files that we place in visitors' computer browsers to store their preferences. Cookies themselves do not contain any personally identifiable information. Although cookies could enable us to relate a visitor's use of this web site to personal information that the visitor has provided, such as an email address, we do not use cookies for this purpose with one exception: for some activities, we use session cookies to ensure that visitors under the age of 13 provide a parental email address to assist with our compliance with the Children's Online Privacy Protection Act. We do use cookies to determine how many visitors we have and how often they visit various sections of our site. "Web beacons" are small pieces of code placed on a web page to monitor the behavior and collect data about the visitors viewing a web page. For example, web beacons can be used to count the users who visit a web page or to deliver a cookie to the browser of a visitor viewing that page. We may use web beacons on this site from time to time for this and other purposes.

#### Email

grkpolebarnhomes.com provides visitors the opportunity to send email to us. We request no personally identifiable information from the parent except his/her first name and email address, which we use solely for the purpose of responding to questions. The visitor's first name and email address are deleted from our system periodically.

#### Customer Service

grkpolebarnhomes.com visitors may email us their questions. Other than an email address, we do not request that users submit any personal information online for customer service inquiries. We may however ask for additional non-personal information to better help us respond to customer service questions. We use the email address to communicate directly with customers about technology-related questions, and provide them with answers that they may find helpful. We do not sell, transfer or share the email address with third parties, with the exception that the information is transferred, disclosed and shared with our third-party agent who uses the information solely to handle and manage customer service, but cannot use it for other purposes and has agreed to maintain the confidentiality of such information. Once we or our third-party agent have had a chance to provide email responses to customer service email questions, the email address is deleted from our system.

#### Business Transfers

In the event that all or substantially all of the assets relating to the GRK Homes, LLC or grkpolebarnhomes.com are transferred or sold to another entity, personally identifiable information may be transferred to the acquiring entity.

## Security

grkpolebarnhomes.com has taken steps to ensure that personally identifiable information collected is secure, including limiting the number of people who have physical access to our database servers as well as electronic security systems and password protections which guard against unauthorized access.
